# William Finck, Race-Traitor

(A Challenge to William Finck to Prove That I'm a Jew) By Pastor Eli James

"Blessed are they which are persecuted for righteousness' sake: for theirs is the Kingdom of heaven. Blessed are you, when men shall revile you, and persecute you, and shall say all manner of evil against you falsely, for My sake." - Matt. 5:10-11.

William Finck has made a very critical mistake. He has asked a very disingenuous question. The question he asks on one of his websites is, "What is Eli James trying to hide?" The fact is that this question is coming from a street-savvy cop, who knows all about the risks I have taken in openly exposing the Talmudic, Zionist agenda. William Finck knows very well why anti-Zionists do not publish their home addresses. With the exception of Finck and Emahiser, every other CI teacher I know uses a post office box. The reason for doing this is quite obvious: to minimize the potential of attacks upon our persons and sabotage of our property by the agents of ZOG. The fact that William Finck would go to the extreme of publishing my home address on one of his websites is nothing short of treacherous. It can have no other motivation than to cause physical harm to me and my family. May Yahshua judge him appropriately for this treachery.

# **Background Information**

"A lying tongue hateth those that are afflicted by it, and a flattering mouth worketh ruin." – Prov. 26:28.

Ever since January of 2011, William Finck has engaged in a good, old-fashioned smear campaign against me and anyone else who does not follow his theology of hatred against non-Whites. He has used the tactic of *ad hominem* attack, in order to make Eli James the issue, so that he can divert attention away from the real issue of his flawed Hybridity Thesis, which denies the fact that Yahweh created the Non-White races. For the record, here is Bertrand Comparet's position on this issue, which I call "traditional two-seedline."

The satanic bloodline crept in through Cain, possibly earlier, among the pre Adamic people. There were pre Adamic people who were not necessarily satanic. There were some pre Adamic people into whom the satanic bloodline came, and there were even some of the descendants of Adam who probably mongrelized. In fact, it is evident they did mix their bloodline for the fact that those living around Noah were wiped out by the flood. The Bible tells us that Noah was perfect in his ancestry, with no mongrelization. He and his family were the ones in the area that were still pure in their bloodlines. This is why the flood wiped out the mongrelized Adamites around Noah. As I documented in "Noah's Flood Was Not Worldwide", this flood did not cover the whole earth as is falsely taught in the churches of today.

<u>I have always taught this same doctrine, without deviation</u>. So, how can I possibly be a "universalist"? Like the Jewish Pharisees, who REDEFINED the word 'Gentile' to mean "non-Jew," when it means no such thing, William Finck has redefined the word 'universalist.' By his redefinition, it means anyone who does not accept his Hybridity Thesis. I have been

broadcasting Identity sermons on the internet since 2003; and there is not a single universalist word that has come out of my mouth in that whole time. The reader is invited to go the archives of <a href="https://www.talkshoe.com">www.talkshoe.com</a> and listen to any of these shows, which number in the hundreds. The three shows are "The Voice of Christian Israel," Christogenos, "and "Yahweh's Covenant People." I have ALWAYS advocated racial separation and White racial pride.

Textbook *universalism* teaches that all non-Whites will be turned into spiritual Israelites at the Judgment Day. I have never taught any such thing, and William Finck knows it. Like a Pharisee, he has redefined the word to suit his own theology and then goes on a rampage of falseds accusations to smear anyone who does not agree with his novel redefinitions and dubious theories. There is only one word that con describes such subterfuge: It is <u>DECEPTION</u>, par excellence. Coming from someone who claims to be Identity, such behavior can only be evaluated for its intended effects on our community.

Given my indisputable record of anti-universalist, exclusivist doctrine, on what basis does William Finck accuse me of universalism? Well, Finck had to invent a cause by which to slander me; and this is the tactic he has chosen. That's just one of the many lies and false doctrine (documented herein) that William Finck has invented, as part of his attempt to commandeer Identity. If I am a universalist, then so is Bertrand Comparet. You can add Dr. Wesely Swift, Dan Gayman, Conrad Gaard, William Gale, Richard Butler, William Fowler, Thomas E. O'Brien, and a host of other two-seedliners to the Finckahiser list of "heretics" and "universalists," because none of them taught that the non-White races are mere hybrids of the fallen angels.

Here is the headline of one of Bill Finck's posts, linked below: "Meet the fictional character, Eli James, who's attempting to pervert "Christian Identity" into "Catholic Identity", and invite all comers!" It is William Finck who is perverting Christian Identity, as I will prove in this essay. Bill knows very well that I am a racial segregationist and that there is nothing "Catholic" about what I teach. I have never taught INCLUSION of the other races. None of his posts contain any evidence that I have ever taught such a thing. He wants everyone in the White Nationalist movement to believe that the non-White races are hybrids of the fallen angels, not created by Yahweh. Thus, all non-Whites become just like the Jews, who ARE hybrids. This lunatic idea provides justification for hatred and violence against non-Whites, because it reduces all non-Whites to the level of four-legged animals. Not even Adolf Hitler ever suggested such a thing! Hitler even shook Jesse Owens' hand after he won the gold medal in 1936. Had Hitler equated Blacks with Jews, as Finckahiser does, I'm sure Hitler would have avoided Mr. Owens.

In addition, Finck's theology of hatred is a carbon copy of what the Talmudic rabbis teach about the "goyim." These Pharisaic rabbis teach that all non-Jews are like cattle, like four-footed beasts and that the Jewish people can dominate and possess us, Talmudically, as if we were their pets or slaves. This is the essence of Jewish messianism, their hidden supremacism. "Goyim were born only to serve us. Without that, they have no place in the world -- only to serve the People of Israel [sic, Jews]." - Rabbi Ovadia Yosef. This is why the Jewish people are encouraged to feel superior towards the goyim. The rabbis also teach that the law only applies to Jews, using this as a justification for lying, stealing, cheating, robbing and even murdering non-Jews.

Finck and the rabbis are more alike than they are different. Finckahiser carries the dehumanization a step further, by declaring that all non-Whites will be exterminated by Yahweh because of their supposed hybrid status. To this claim I say, PROVE IT, Finckahiser. Show us the verse that says, "All non-Whites are hybrids of the fallen angels." I want to see the reference,

chapter and verse.

This is why I refer to Finck and Emahiser's doctrine as the Aryan Talmud. It is based purely on their hatred of all non-Whites. <u>Sadly, their behavior also demonstrates their hatred of any White person who might disagree with their theology of racial hatred</u>. Those who preach hatred invariably wind up hating anyone who does not share their hatred, and that includes those of their own race. <u>So much for Finck's claim that he loves his own race!</u>

# The Covert War Between Identity and Jewry

When I was at Bill Finck's home in the fall of 2010, I asked him, "Do you think it's wise to publish your home address on your website?" He was not concerned. I thought he was recklessly endangering his mother and grandmother, with whom he lives.

There is another reason why William Finck's question, "What is Eli James trying to hide," is disingenuous. William Finck himself, on my shows, has asserted that, unless some actual crime has been committed, there is no sin. There is no such thing as a thought crime! I agree with this 100%, as you cannot prove a thought crime, not until the crime has actually been committed, or if proof of a conspiracy can be obtained. Yet, here is William Finck, in a highly accusatory manner, suggesting that I am "hiding something." Yet, he can point to no act of betrayal or treachery, with which I have ever been associated. No White person in this world can say, "Eli did me wrong"...unless, of course, the "wrongdoing" is merely disagreeing with your theology. I have made many enemies among the dogmatists within Identity. But none of them have ever been slandered or harmed be me in any way.

All my enemies can do is to create suspicion, even though no crime has been committed. Since Mr. Finck does not specify exactly what I might have done wrong, he is quite obviously engaging in slander. Unproven accusations simply do not count!!! Finck's disingenuous question is designed to create suspicion as to what I might do at some point in the future, as if I am leading the flock down the wrong path! We'll see who the false teacher is very soon! Let's see, I have been exposing Jewish perfidy since 1979. Is anyone going to seriously believe that I will suddenly betray the movement after 32 years of dedicated service?

There are many Bible verses that deal with those who concoct false charges against an innocent person:

Beware of false prophets, who come to you in sheep's clothing but inwardly are ravenous wolves. - Matthew 7:15.

I appeal to you, brothers, to watch out for those who cause divisions and create obstacles contrary to the doctrine that you have been taught; avoid them. For such persons do not serve our Lord Christ, but their own appetites, and by smooth talk and flattery they deceive the hearts of the naive. - Romans 16:17-18 **ESV.** 

See to it that no one takes you captive by philosophy and empty deceit, according to human tradition, according to the elemental spirits of the world, and not according to Christ. - Colossians 2:8.

Beloved, do not believe every spirit, but test the spirits to see whether they are from God, for many false prophets have gone out into the world. - 1 John 4:1.

For such men are false apostles, deceitful workmen, disguising themselves as apostles of Christ. And no wonder, for even Satan disguises himself as an angel of light. So it is no surprise if his servants, also, disguise themselves as servants of righteousness. Their end will correspond to their deeds. - 2 Corinthians 11:13-15 ESV.

So, here is the point of all this. You, the reader, must decide. One of us is an impostor. One of us is a race-traitor. Either it is Eli James, a 32-year veteran of the fight against ZOG, or it is William Finck, a Johnny-come-lately, who has anointed himself as the Grand Inquisitor of all those who do not genuflect before "His Excellency," the apostle of genocide against all non-Whites. This is what is at stake, Christian Israel. Never mind that no one in the history of planet earth has ever taught such a doctrine, let alone try to justify it from Scripture.

William Finck is deliberately trying to undermine the ministry of one of the most well-established, public critics of Jewry and Judaism. In doing so, he has concocted a smoke and mirrors theology, which only a small handful of people can even tolerate. INSTEAD OF ATTACKING THE JEWS (shades of Martin Lindstedt!), BF has been diligently and zealously **obsessed** with "exposing" Eli James, ever since January, 2011. That's when he and Emahiser began their public accusation campaign, calling me a "*liar*," "*heretic*" and "*universalist*."

Given that insult to everyone's intelligence, I had no choice but to publicly challenge his novel theory about the non-White races. Since that day, William Finck has gone on a rampage of false accusations and character assassination. Besides numerous insulting comments and articles about me, he has put out at least three videos, in which I am depicted as a fat Arab, a hook-nosed Jew, and a "universalist." His main tactic since last January has been to put out an avalanche of rumors, suggesting that my use of an alias somehow proves that I am a "Jew." Thus, he has turned a non-event into a federal offense. The latest video I have found is called "Unmasking Eli James," in which I reject Finck's absurd "Yahweh is still resting" doctrine. [Link: http://www.youtube.com/watch?v=yLUPr-tg7xk&feature=related | The beginning of the video, which concerns Matt. 15:22-28, actually confirms that I am NOT a universalist, as I clearly state that none of the promises made to Abraham's direct descendants can be transferred to non-Israelites!!! But, to Finck's fobs (friends of bill), any doctrine that does not assert that all non-Whites are meant to be exterminated by Yahweh is "universalism." Whoever produced the video cuts the audio off before Verse 28, where Yahshua states very clearly, to this Canaanite woman, "Great is your faith," and He healed her daughter. Finck and his fobs don't like to quote that verse. It annihilates their Pharisaic doctrine. Finck teaches that Yahshua "had no choice." Precisely, because the Canaanite woman had blessed our seed, as per Gen. 12:3. Yahshua is not going to punish someone who is not guilty of a crime!!! He would be violating His own laws!!!

God forbid! But, William Finck wants to punish me for violating his own Pharisaic non-crime: using an alias!

This is the type of misrepresentation of Scripture that is coming from the Finckahiser cult. I would say to Finck's fobs, "What part of Matt. 15:28 don't you understand?" That verse is in perfect conformity with Gen. 12:3 and Rev. 3:9. None of these verses state that non-Whites are all crypto-Jews. Nor do they state that all non-Whites will be exterminated. In fact, they say the exact opposite, namely, that SOME non-Israelites will survive the Judgment Day, under our dominion. The clearest declaration of this prophetic fact is contained in Zech 14, the subject of which is the "Day of the Lord." Verse 16 is an absolute refutation of the Finckahiser.

Extermination Thesis. Those nations will be observing the Feast of Tabernacles, UNDER OUR DOMINION. Can my position be any clearer, William Finck? Can your denial of Scripture be any more Pharisaic?

### My Record Versus William Finck's

FACT: Having been in this movement since 1979, I have never betrayed any of my fellow Christian Israelites. Nor has any White person been injured by me in any way. Nor can William Finck say that I have. My disagreement with his theology does not make me a liability to the movement. Nor does it make me a "threat to Identity." On the other hand, Extermination Theology presents numerous moral and doctrinal impediments to the success of Christian Identity. Aside from the doctrine being un-Scriptural, it is the kiss of death for Identity. Christian Israel, be wary when Judas smooches up to you with flattering words and phony kisses. Any White Judeo-Christian, a potential convert, who falsely believes that CI teaches the extermination of all non-Whites, would immediately turn away in disgust. That is why this issue is so important. This is why I cannot let this matter rest. It's hard enough to attract Whites to the truth of CI, which has always taught racial separation. The Finckahiser doctrine is calculated to drive potential White converts away. Their exclusivity is the exclusivity of a cult; and they know it. This is also why we are now witnessing this self-serving betrayal by one at the expense of another.

Their doctrine guarantees that they will never come back into the fold. It is also repulsive precisely because it is un-Scriptural, as I am demonstrating in this essay. I have received dozens of messages from White separatists who find it repugnant. Many have stated that they would never have come to Identity, had this been a part of our theology. For this reason, Finck and Emahiser are actually driving people away from Identity. The ADL is very happy about this. The Hybridity Thesis is a very sinister and clever way of minimizing the impact of Christian Identity. Only the law-breaking Finckahiser cult will ever adhere to this nonsense.

I have done battle against many false doctrines, within Identity and without; but this is the first time that an organized cult has used the internet to smear me. Be aware that none of their emails, videos and audios refute what I teach. Nor do they explain that what they really teach is EXTERMINATIONISM. That is why they must focus on ME, their adversary, rather than reveal their true doctrine. This is persecution by accusation, period. As Shakespeare said, "Methinks that William doth protest too much."

The simple fact is this: My ministry attracts White people to Identity. The Finckahiser ministry drives them away – in droves. But his small handful of fobs are very busy attacking me on the internet; and I do not have a stable of scribes to assist me, as BF does.

Perhaps I should feel flattered by all the negative attention that Finck is giving me. It just proves that he cannot defeat me in open debate. In open debate, all I have to do is ask the question, "What is your proof that the non-White races were NOT created by Yahweh?" There is none. "What is your Scriptural proof that Yahweh hates these other races?" There is none, although He DOES hate Esau and his descendants. This is very clear. Let the people hear both sides. The whole world would love to hear the lame responses that I have heard from Finck and Emahiser. Let's schedule a debate on RBN, let's say with Rick Adams, Carolyn Yeager or Deanna Spingola, or even Clay Douglas. Why haven't you openly preached exterminationist doctrine to them? Because you know they will laugh at you, that's why!

"Only the White Race is a pure race," says Finck. Where is the **science** behind this pronouncement? There is none. Since Finck is only catering to a small cult of deluded racists, his accusation that I am a "Jew" is more than frivolous. It is treacherous and scandalous. But Finck seems to thrive in the atmosphere of scandal. Very Jewish!

FACT: No one has a better record of supporting White prisoners in getting CI literature into the prison system than Eli James. I have challenged numerous states, including Wisconsin,

Tennessee, Oregon, Colorado and Florida, demanding that they allow CI literature to be delivered to their White recipients. In each case, my formal complaints have succeeded. Would a Jew even bother to go to such trouble? The fact is that infiltrators – if William Finck is trying to imply that I am an infiltrator – have always been all talk and no action. Like Hal Turner, they stir up the pot but do nothing of value for people in the patriot movement. Using macho rhetoric, Hal Turner fooled thousands of sincere patriots. Finck is doing the exact, same thing, with a pittance of phony theology thrown into the mix. Whenever a newcomer sets himself up as the Grand Inquisitor of an entire movement, the alarm bells must be ringing, and suspicions about his motivation must be considered. Whatever Finck's motivation, his tactics are those of a provocateur who is making ridiculous accusations based on little or no evidence. He is also recklessly implicating himself in this manner. BF was able to restrain himself while he was my co-host; but once this self-proclaimed "high priest" of Identity was on his own, his true colors began to show. From that point on, disregarding all reason and Christian morality, his modus operandi became *ATTACK*, *ATTACK*, *ATTACK*.

FACT: I can say that my articles, radio shows, speeches at anti-ZOG rallies, and websites, <a href="www.anglo-saxonisrael.com">www.anglo-saxonisrael.com</a> and <a href="www.killthebank.net">www.killthebank.net</a>, have done more to alert White people to the threat posed by organized Jewry than any other sources of information. There is no reason for me to take these articles down, because they are excellent pieces of scholarship and they don't question my ancestry. Nor do they contain any hint of his doctrine of exterminationism. That is something that came out of the blue, late in 2010.

FACT: <u>Bill Finck has known about my alias for this entire period</u>. So, it is quite clear that Bill Finck had no problem, either with my theology or my alias, for two and a half years. *What changed*? I have not changed my teachings or my modus operandi whatsoever. It is William Finck who changed. He dropped the H-bomb (<u>Hybridity Thesis</u>) upon Christian Identity, claiming that the Bible teaches that all non-Whites are hybrids of the fallen angels.

This doctrine is completely novel. No one had ever preached it before, not even the two-seedliners, such as Swift and Comparet. All previous two-seedliners have taught that the "beast of the field" in Gen. 2&3 is a reference to one or more of the non-White races. At the 34 minute mark of the show cited below, Finck refers to this supposedly obsolete position as "Orthodox CI." This is a correct; and this statement is an admission to the fact that his doctrine is unorthodox within CI. Furthermore, none of these CI teachers had ever suggested that the non-White races were not created by Yahweh.

For this same period of 2.5 years, William Finck had my complete trust. He had the passwords to my website and my talk shows. He ran my talk shows in my absence. <u>During this time</u>, William Finck never once accused me of being a "Jew" or a "universalist."

FACT: In 2010, I testified at a civil trial in Wisconsin, on behalf of one my local congregants, in a child custody dispute. The mother of his little boy was trying to prevent him from retaining visitation rights with his son. Her lawyer had argued that, because of his White Nationalist/Christian Identity affiliations, that he was an unfit parent. At previous hearings, her lawyer had made his case on the premise that the father was a "racist, neo-Nazi." The judge had been very sympathetic to this line of argument. My testimony, which demonstrated the Biblical basis of racial separation, caused the judge to rule out that line of argument. To the prosecution's

disappointment, the judge restored the father's visitation rights, based upon his continued payment of child support and temporary oversight of a court-appointed "counselor."

As a combat veteran of the Vietnam War, twice wounded in action, the first thing you learn is not give your position away to the enemy. Using that same strategy, I have used numerous pennames as aliases, as a contributor to various CI newsletters, in my battles against ZOG. Most people in Identity are behind-the-scenes supporters, often rejected by their own families, so they know how easy it is to make enemies; but I have been out on the streets, on the radio and in numerous videos. This activity exposes me and my family to inevitable dangers. Eliot Ness had very good reasons for choosing unmarried men as his Untouchables. One of the mob's favorite tactics is to threaten a man's family. William Finck is not exposed to such dangers, as he resides in rural New York State, far away from Jews and communists. How many Jews do you know of, who are combat veterans? If any Jews are found in the military, they are NEVER in combat positions. It's always doctors, lawyers, dentists, supply sergeants, communist spies, etc.

FACT: My record proves I'm no Jew; but Finck's accusations bring joy to those who are ignorant of my standing in the WN community or who care little or nothing for Christian ethics. Here, Finck is clearly trying to elevate himself at my expense. Another Jewish tactic!

William Finck, however, does stand out as someone who is wreaking havoc in the Christian Identity and White Nationalist communities, by using the internet to spread dissension and discord. Just think what William Finck could accomplish if he were trying to DO GOOD!!! The Golden Rule states, "Do unto others as you would have them do unto you." Those who violate this law will see their machinations come down upon their own heads. Those who practice "the end justifies the means" are doing Satan's Talmud proud!

# My DNA Analysis

Some of Bill's followers have asked to see my DNA analysis, so here it is, from my DNA lab, 23andMe.com. My maternal haplotype is H7, which is a subgroup of H, which is a subgroup of R0. Here is the readout:

Haplogroup: H, a subgroup of RO.

Age: more than 40,000 years.

Region: Europe, Near East, Central Asia (this is where the Indo-Aryans originated).

Populations: Bosques, Scandinavians.

Highlight: Mitochondrial DNA extracted from the remains of St. Luke belonged to haplogroup H.

Note the highlight. On my maternal side, I am related to St. Luke. My ancestry is 100% Germanic Israelite, with most of my ancestors coming from the Bad Wirtemburg area of Germany. The major cities of this area are Stuttgart, Mannheim and Heidelberg. My ancestors have been Danube Swabian (a branch of the Ostrogoth migration) peasant farmers for more than 2,000 years, specializing in orchard-keeping: pears, grapes, peaches, plums, etc. No Jews have ever been in this profession. The Ostrogoths who migrated the farthest west became known as the Visigoths, who controlled Spain at the time of the Moorish/Jewish invasion. Since my ancestors are peasant farmers, the likelihood of my having any non-Germanic, non-Israelite blood is virtually zero. I wonder if Finck can say this! I grew up eating pork chops, bratwurst and blood sausage, so there is no Jewish tradition whatsoever in my household. I have since given that cuisine up, once I realized that True Israel does not indulge in those things. I was

raised Catholic; and my mother hated Jews with a passion. She adored Adolf Hitler and Richard Nixon. (I know that Finck's fobs have been digging into my past and know of Catholic, Germanic upbringing, but they do not reveal these things, because the truth doesn't fit the false picture they are creating about me.)

Another famous person in the H haplogroup is, according to my DNA analysis, *Marie Antoinette*. This means that Eli James, Marie Antoinette, and Luke the Evangelist have a maternal ancestor in common. <u>How many Jews can say that</u>? That fine lady was, most probably, a Scythian Israelite or a Cimmerian Israelite.

If any fobs (friends of Bill) do not believe this analysis, I will be happy to provide you with a sample of my saliva. I'll meet you anywhere in the Chicago area. Bring an unopened test package with you, and I will provide you with a sample right before your very eyes. We will both seal the package and drop it in the nearest mailbox. Be prepared to pay the fee, which is usually around \$100.

My paternal haplogroup is R1, which is Indo-Aryan as well. <u>Both of these haplotypes, H</u> and R1, are traceable from the area from which Aryan Israel migrated, the bulk of them coming through the Caucasus Mountains, starting around 700 BC. Those who migrated straight west travelled along the Danube River. This is why my ethnic group is known as the *Donau Schwaben* (the Danube Swabians). Ninety percent of the Basques are haplogroup R1. Adolf Hitler considered the Basques to be even whiter than the typical German.

Here is what 23andMe has to say about Haplogroup R1:

Haplogroup R1 is the dominant <a href="https://haplogroup.com/haplogroup">half of all men</a>. [It would probably be around 100%, were it not for the influx of non-Whites into Europe today. This is also the haplogroup of King Tut, who was a White man. – Eli] After being confined to the continent's southern fringes during the Ice Age, it expanded rapidly in the wake of the receding glaciers about 12,000 years ago. <a href="https://www.garious.com/yarious.com/branches-of-R1">Warious branches of R1 also trace the many migrations that have shaped Europe since then, from the arrival of farmers between about 10,000 and 7,000 years ago to the movements of ethnic groups such as the Anglo-Saxons and <a href="https://wikings">Vikings</a>. Some famous people in the R1 category are John Adams, Nicholas II of Russia, James Buchanan, Franklin Pierce and William McKinley. I would say that my DNA is in pretty good company.

Unfortunately for Bill, the surname, *Fink*, is very common among Jews. *Finck* is one of its variants. Here is a website about this Jewish surname: <a href="http://www.houseofnames.com/fink-family-crest/Jewish">http://www.houseofnames.com/fink-family-crest/Jewish</a>. Bill, what's good for the goose is good for the gander. But I won't suggest that you're Jewish – by genetics. I will let your behavior speak for itself.

### Some Background Information About My Relationship With William Finck

"Debate your cause with your neighbor; and betray not a secret to another." - Prov. 25:9.

William Finck, in an undisputable act of betrayal, has, like an agent of ZOG, published my home address on one of his websites. I will not here provide the link, so as not to make it any easier for the Zoggites to find me. Nevertheless, the CI community is well aware of Finck's posts about me.

FACT: No true patriot would ever do this without first providing evidence of guilt for some specific crime. {Count #1, betraying an Israelite to the enemy.} For 2.5 years, ever since Bill got out of prison, he has known about my dual identity. For 2.5 years, he had no problem

keeping my secret. But now he has broken many of Yahweh's laws, in his attempt to defame my character. The law says that if you have a grievance against someone, you are supposed to go to that person and confront him with your evidence, until you get a satisfactory answer. Upon presenting the accused with the evidence, if the accused provides you no satisfaction of innocence, then the matter is to be presented before the Council of Elders, whereupon a trial will be held. At such a trial, both sides can present their cases.

The account of this law is contained at Matthew 15:15-18:

Now if your brother should do wrong, you must go censure him between you and him only. If perhaps, he should hear you, you have gained your brother. But if he should not hear, take with you one or two besides, in order that by the mouth of two witnesses, or three, is every matter established. And if he should ignore them, tell it to the assembly. Then if also he should ignore the assembly, he must be to you as the heathens and the tax-collectors. Truly I say unto you, whoever you shall bind upon the earth shall be loosed in heaven." - William Finck translation, Christogenea New Testament.

I have committed no crime; and William Finck has not provided any evidence that I have. Under no circumstances may an Israelite engage in a rumor campaign. William Finck, when you accused me of being a "Jew," you were supposed to first present your evidence to me, personally. You have not done this! Nor have you provided it to anyone else, because I know you have none. "An accusation against an elder you must not receive publicly, except 'by two or three witnesses." - I Tim. 5:19, Finck trans. Nor have you complied with this stipulation of the law. Bill Finck, where is your evidence? Produce your witnesses. Why are you engaging in this charade of mock righteousness? You are mocking Yahweh Himself, William Finck! You have violated the first provision of Matt. 15:15-18. {Count #2, public accusation without first confronting the individual.} Instead of confronting me with your evidence, you instead started an internet smear campaign, which continues to this moment. This is your third violation of Yahweh's laws. {Count #3, rumor-mongering. Leviticus 19:16: You shall not go about as a talebearer among your people; nor shall you take a stand against the life of your neighbor: I am *Yahweh.* Nor have you presented the required two or three witnesses (Numbers 35:30; <u>Deuteronomy 19:15</u>). {Count #4, failing to provide other witnesses.} <u>The fact is that you</u> haven't provided any evidence at all. Your only "evidence" is the *insinuation* that my use of an alias "proves" that I'm a Jew. Try taking that to a judge, Bill. Try taking that to Judge Lifland! As a cop, you know very well that an insinuation counts for nothing. Yet, you masquerade before your followers as a man possessed of righteous indignation. What a joke!! Move over, Diablo, you've got competition!!!

When William Finck was in the halfway house, waiting to go home from prison, I called him on my home phone. On the phone's screen, he saw the name I use for non-Identity purposes. So, he asked me about it right then and there. I told him that I have to keep my Identity life separate from my business life, as I would lose my livelihood if my clientele ever found out about my anti-Zionist activities. Having a home, family and business to run is something that cannot be done with controversies swirling around one's head, and losing customers to boot. This is the obvious fact of the matter, as anyone in the front lines of the anti-Zionist movement clearly understands. There are many others who have asked me about my dual identity. I have given them the same explanation; and they, unlike William Finck, have kept my secret. William Finck DID keep my secret for 2.5 years; but, now he has become a betrayer of secrets, because of my stance against his extermination thesis. He deceitfully claims that I am a suspect of some fictitious crime, because I use an alias.

The reality is that, during this 2.5 years, Finck was **hiding** his extermination thesis from those of us in Identity. All of the listeners of my shows are aware of this fact, as it was only in the last couple of months, in late 2010, that he began to drop hints of this theology. For this period of 2.5 years, he used my talk shows to establish his credibility as a CI scholar. No one had ever heard of William Finck until I brought him aboard on *Christogenos*, a radio show which I created just to have Bill be my interview guest. My reason for doing so was to have him help me in my disputes with the Paul-bashers within the CI movement. I was having good success explaining to them that the problem was not in Paul's original Greek. The problem is in the universalistic translations. The fact that Bill had written a CI version of the New Testament, directly translated from the Greek, would be of great effect against the Paul-bashers. Thus, the truth would be made plain to all CI believers, many of whom have legitimate doubts about Paul's Epistles, because of the poor KJV translations.

For at least two years, while Bill was still in prison, we had exchanged many letters about the horrible problems in the KJV, concerning the deliberate misrepresentations of Paul by the antinomians of Judeo-Christianity. In all of these matters of mistranslation, we were in total agreement. In all matters identifying the True Race of Israel, we were in total agreement. I have all of his handwritten letters to me in my files, so there is no way that Bill Finck can say otherwise. So, even before he got out of prison, I invited him to be on my talk shows, to help me explain to the CI audience the profuse deceptions surrounding the supposed universalism of Paul. In this regard, it was our intention to demonstrate the fact that the original Greek does NOT support the universalist, dispensationalist, antinomian theology of modern "Christianity." Bill's expertise in the Greek language showed me that he understood this matter in much greater detail than I, and I was overjoyed to hear that he was willing to be on my talk shows, to help me explain these things to those who have a real interest in studying the Bible. I think we accomplished this task in a very scholarly manner, going through all of Paul's epistles on my various radio shows, although Bill's habit of name-calling caused many to stop listening to the programs.

During this time, Wlliam Finck never once suggested his novel Extermination Thesis. It was Clifton Emahiser, who was trying to persuade me of this theology. Since Bill is Clifton's protégé, I began to wonder where Bill stood on this issue; but he did not openly declare himself until I published "Beast of the Field," which was my refutation of Clifton's arguments. Bill was waiting to see how I would react to Clifton's thesis. Although we had had a few brief discussions in private, by phone, we had never discussed this subject on the air, but it was becoming increasingly obvious that Bill was trying to sneak this doctrine in, hoping that I would not challenge it. I knew that a big confrontation was coming. Many people advised me to avoid this confrontation; but I could not do so, because the Extermination Thesis is so terribly flawed that I could not, in good conscience, endorse it. For a thorough explanation of why I reject their theology, please read "Beast of the Field." [http://anglo-saxonisrael.com/site/beastofthefield]

My publication of BOF forced Bill to declare himself as being with Clifton on this issue. Rather than keep the debate on a scholarly, up front, basis, William Finck resorted to the tactic of character assassination. He also engaged in the practice of ridiculing my positions in other areas, such as the Oneness Doctrine, 2012, and Ron Wyatt. In this manner, the two-headed monster, Finckahiser, began their smear campaign. Unknown to me at this time, he also started turning some of my listeners against me, on his own shows. Need I remind you that *ad hominem* attacks are what the Jews do to people? *Ad hominem* is what people do when they cannot win the argument in an open debate. Rather, they change the subject and attack the individual. Clifton

started doing this to me at least six months before I published "Beast of the Field." <u>Within Christian Identity, the use of such immoral tactics is unprecedented.</u> Bill and Clifton were the first ever to use such tactics, which, although they began surreptitiously, they became public on Jan. 14, 2011. {Count #5. Ad hominem attack, false accusation, ridiculing a fellow Israelite. See Matthew 5:22.}

Personal to Bill Finck: Jewish IS as Jewish DOES.

# William Finck Betrays Eli James

"The words of a talebearer are as wounds, and they go down into the inner most parts of the belly." – Prov. 25:22.

Talebearers are vindictive. Instead of keeping the debate scholarly, William Finck has used his websites to start a relentless smear campaign against me, putting out articles ridiculing me and videos depicting me as a "Jew." {Count #6, public accusations without a cause, Psalm 25:3.} Then, he started ridiculing anyone who disagrees with his Hybridity Thesis, even going to the extent of saying, "Anyone who does not agree with this position is a heretic." {Count #7, blasphemy.} And by this declaration he was including "all previous" two-seedliners, including Dr. Wesley Swift, Bertrand Comparet, William Gale, Dan Gayman, etc. This is quite a sweeping, arrogant pronouncement. (As Paul says, "The need to boast is not truly beneficial." - II Cor. 12:1, Finck trans.) None of these men had ever declared that all of the non-White races were merely hybrids of the fallen angels. The archbishop of Norwich has issued his Bull.

The anti-Christian character of all of this activity is blatantly obvious; and anyone who encourages William Finck in this process is just as guilty of violating Yahweh's laws against deceitful practices and lying. Anyone who stoops to the level of lying and deceit automatically disqualifies himself from membership in Christian Identity. Obedience to Yahweh's laws is the first prerequisite of being an Adamic Israelite. "For this is the love of God, that we KEEP His commandments: and His commandments are not grievous." - I John 5:3. By deceitfully declaring me to be a "Jew," William Finck pretends that he can ignore Yahweh's commandments.

"Be not deceived." After all, it was the deception of Eve that got us all into this predicament we are now in. After using my talk shows to establish his credibility, William Finck has stabbed me in the back, trying to destroy my credibility with a transparent smear campaign. How Jewish! Those who practice deception should be exposed, as Paul clearly declares. "Them that sin rebuke before all, that others may also fear." (I Tim. 5:20.) I am following Paul's advice, exposing William Finck as a reprobate. If William Finck can stab me in the back, he will do the same to you, brothers and sisters, if you do not fully accept all of the pronouncements of his bully pulpit!

William Finck, what part of "Thou shalt not bear false witness" don't you understand? Since our split over the Finckahiser Hybridity/Extermination Thesis, William Finck has spared no time or effort to speak all manner of evil against me, calling me names, such as "Jew," "heretic," "liar," "fool," "universalist," etc. Of course, all such name-calling is strictly prohibited by the Holy Scriptures. If you make an accusation against someone, you are supposed to provide evidence. Where is the evidence of my Jewish upbringing? What synagogue did I attend? When and where was my bar mitzvah? Who was my rabbi? Finckahiser cannot provide any evidence, because there is none. Instead of providing any evidence of my supposed Jewish heritage, Finck just keeps adding more false accusations to the list, as the police commonly do

when they don't have any evidence against the suspect. By loading up the list of charges, they hope they can make one of them stick. This is what William Finck is doing to me on his talk shows and websites. The Finckahiser rumor mill cranks out more and more trash on an almost daily basis; but those fobs with itching ears can't wait to hear more! What a disgusting display of guile and childishness! For this reason, none of his followers deserve to be called "White" or "Christian" or "Identity."

Since January of 2011, Bill Finck has gone on a rampage of accusations against me, all of which are false, except one: the fact that I use an alias. In a recent post on his website, in which he maliciously publishes my home address for all of my Jewish and communist enemies to see, he asks the question, "What is Eli James trying to hide?" The answer is very simple. I have been trying to hide my identity from my Jewish and communist enemies, as anyone living in a big city would have the common sense to do. Publishing this information on the web is a clear act of RECKLESS ENDANGERMENT. Of course, Finck knows this. He is a cop, after all. In fairness, Finck should post all of his violations of Yahweh's laws on his Zogbots site.

To those who have asked, I have told them that my public persona is based on a completely made-up name. Yet, Finck's fobs assert that it's a "Jewish name." It's a name I made up when I was the singer in a band. One of the links that Finck provides is a link to the history of the surname that I invented. The link says, "*Sorry, there is no history of this surname*." That surname has no history precisely because I made it up!!! So, how is this evidence that it is a Jewish surname? Quite the contrary, that surname cannot be connected to Jewish heritage in any way, precisely because it is an invented name. Finck's fobs provide their own evidence that they are liars.

William Finck's insinuation that I am trying to hide my "Jewishness" is patently absurd; and he knows it. But, he is not above using the Jewish tactic of rumor-mongering against his theological enemies. This is very telling about his own motivation, which betrays a lot of Jewish tactics and attitudes.

"The errors of some men are manifest beforehand, going ahead into judgment, but others then follow after. In like manner also are the good works manifest, and those being otherwise are not able to be concealed." - I Tim. 5:25, Finck trans. Bill, your attempts to conceal your own motivation will fail. It is so obvious that your actions are those of a reprobate, that you cannot possibly continue this masquerade. As Jesus said, "All things will be revealed."

Also, it is very important to understand that he kept my secret until January 14, 2011. His betrayal began when I challenged his theology. That's what this is all about. But, since he cannot win his theological argument in open debate, he and Clifton decided on the tactical maneuver of attacking my person; and this is what they have done since then.

The day is coming when Finck's name will be become a household proverb, like that of Benedict Arnold. Anyone who is the object of character assassination will say, "*I got fincked*."

"What is Eli James trying to hide?" This question is as silly as asking a klansman, "Why don't you publicize your Klan membership to your friends, neighbors and customers?" Can you see a Klansman going around the neighborhood saying, "Hello, all you Negroes, liberals, Jews and Judeo-Christians, I am a member of the Ku Klux Klan?" I don't think so, William Finck. As a cop, you know EXACTLY WHY many patriots hide their identities from the pro-Zionist world in which they live. Their homes and businesses would be in jeopardy, were their underground activities discovered. Whether they wear masks or use aliases, their objective is the same: to prevent harassment and attacks upon themselves and their families by the forces of ZOG. Only the most gullible people would believe the proposition that anyone who uses an alias must be a

<u>"Jew."</u> By turning this molehill into a mountain, and adding tons of rubbish, you have proven yourself to be still as tyrannical as you were when you were a brutal cop.

So, here, I will counter your argument with a question of my own: "Why did YOU HIDE your true involvement in the death of Arnaldo Ortega from us?" When Brian Akira revealed the fact that you were imprisoned for causing the death of that person, YOU LIED TO US! You told us that you were simply sitting at your desk, while that defenseless individual was being beaten to death. To make your story even more sympathetic, you told us that you were maliciously prosecuted for trying to help those officers who were being falsely charged with the crime.

So, while you go to great lengths to make yourself look good, you go to even greater lengths to make me look evil – over an alias, while you have been convicted of a far greater crime; but the truth is coming out, and there is nothing you can do about it, Bill. The jig is up. You have been exposed as a malicious defamer: Diablo, the false accuser.

The reality is that Eli James is to William Finck as Valerie Plame is to George Bush. Publishing my personal information on your website is an unconscionable betrayal. William Finck, you are treading down the path of Nachash. If anything happens to me or my family, you will be held directly responsible by Yahshua. Among his many false arguments, Bill Finck is trying to convince you of the idea that my use of an alias negates 32 years of two-seedline teaching. As I said, in this time, I have never betrayed anyone to ZOG or violated the rights of any White person. The REAL QUESTION IS: "What is Bill Finck up to?" In this world of fighting against ZOG, blowing the cover of a true patriot is about the lowest thing a White man can do. If you watched both the above videos about Valerie Plame, the important word was 'retaliation.' William Finck's vendetta against me has nothing to do with whether I'm a Jew or a universalist. <u>It's all about retaliating against me for taking a stand against his garbage theology</u>.

In contrast to William Finck, I have broken NO LAWS. I have only disagreed with his theology and rebutted his false accusations. Taking a stand against Finckahiser's phony theology is my only "crime." Taking advantage of other people's ignorance of the real issues involved in this case, Bill and Clifton have performed an evil work. Showing the zeal of the Pharisees in their attempts to entrap me, they expose themselves as being members, in spirit, of that priesthood.

### My Legitimate Reasons for Assuming a Dual Identity

And the King shall answer and say to them, 'Verily I say unto you, inasmuch as you have done it unto one of the least of these my brethren, ye have done it unto Me.' - Matt. 25:40.

Jesus Christ, Himself, on at least one occasion, found it advantageous to hide himself from His enemies. The account is in John, Chapter 8: "Then they took up stones to cast at Him: but Jesus hid Himself, and went out of the temple, going through the midst of them, and so passed by." - John 8:59. So, by disguising Himself, Yahshua was able to sneak out of their company. Yahshua disguised Himself on at least two other occasions, at John 7:10 and at Luke 24:15-26.

Martin Luther, when he was in hiding from the papacy, under the protection of Frederick III, the Elector of Saxony, used the name of *Junker Georg* as an alias, in order to hide his identity

from the Pope's forces. Frederick III saved Luther's life. He was one of the Saxon lords who had the right of voting for the election of the next Emperor.

Mr. Stanley, of Stanley and Livingstone fame, changed his name from John Rowlands to Henry Morton Stanley, because he was the illegitimate offspring of the town drunk and a 19-year-old whore. In those days, bastards were frowned upon. Today, they become Presidents. A change of venue and change of name, and viola! – the famous reporter for the New York Herald was "born." Did John Rowlands defraud anyone by changing his name? I don't think so!

So, if Jesus Christ can hide Himself, if Martin Luther can hide himself and use an alias, if John Rowlands can change his name, why can't Eli James? Who says that changing one's name proves malicious intent? *William Finck insinuates that it does!* On the other hand, spreading rumors about people being Jews or universalists, without any proof whatsoever, is a violation of Yahweh's laws. If there is any malicious intent, it's coming from the Finck/Emahiser crowd. Those people find it advantageous to smear people by using name-calling, rumor-mongering, innuendos, half-truths, outright lies, and creating an atmosphere of suspicion as tactics in their open hostility to other White people, all while they make themselves out to be, oh, so righteous! Very Jewish!!! Nor is there any law in the Bible that says, "Thou shalt not use an alias." That is exclusively William Finck's Talmudic commandment. You won't find it in his Christogenea New Testament either. It's Bill's main contrivance in his retaliatory vendetta against someone who has done him no wrong.

None of the above named were ever accused of wrongdoing for hiding or changing their identities; but William Finck assures the world that Eli James is up to no good!!! Let's see, I've been in this movement since 1979; and I haven't betrayed anyone yet! On the other hand, William Finck is out of prison for two and a half years, and he is creating dissension and hostility within the ranks of the Christian Identity movement; and he is leading people astray with his popish dogma of the Extermination Thesis. Only one of us has a **hidden agenda**. One of us is playing the role of Judas; and it's NOT Eli James. Yahshua says, "*Blessed are the peacemakers*," not the troublemakers. If people disagree with you, you must use the art of persuasion, not the art of bullying.

It's funny that those who accuse me of being a "name-changer" are some of the biggest name-callers!! Mr. Finck is famous for his angry diatribes against his own kinsmen, especially those CI women who have had the temerity to object to his bullying! "Fool," "whore," and "clown" are some of his favorite, printable expletives. Of course, this obvious show of disrespect towards his own White brethren is totally forbidden by the Scriptures. First of all, Paul condemns it. "I therefore, the prisoner of Yahshuah, beseech you that ye walk worthy of the vocation wherewith ye are called, with all LOWLINESS AND MEEKNESS, with longsuffering, forbearing one another in love; endeavoring to keep the unity of the Spirit in the bond of peace." — Eph. 4:1-3. Bill Finck has not demonstrated any such forebearance towards his brethren. His words and actions betray the opposite.

Jesus also tells us that we should not be like the heathen and lord it over our kinsmen. Rather, we should humble ourselves and be of service.

"The kings of the nations exercise lordship over them; and they that exercise authority upon them are called benefactors. BUT YOU SHALL NOT BE SO: but he that is greatest among you, let him be as the younger; and he that is chief, as he that does serve. For which is greater, he that sits at meat, or he that serves? Is not he that sits at meat? BUT I AM AMONG YOU AS HE THAT SERVES." - Luke 22:25.

Yet, Finck's followers do not upbraid him for his obvious displays of disrespect towards White people. "Now I exhort you, brethren, to watch out for those who cause dissension and scandal contrary to the teaching which you have been instructed in, and TURN AWAY FROM THEM." Indeed, such as they do not serve Yahshua Christ Our Prince, but rather their own belly, and through smooth speaking and fine language they seduce the hearts of the innocent." - Romans 16:17-18, William Finck translation, Christogenea New Testament. William Finck, when will you follow the advice of your own translation? Why are you defaming the very person who helped you to establish yourself as an Identity teacher? Why are you doing this? That is the important question for Bill Finck to answer.

It is simply not true, as WF is trying to imply, that using an alias proves malintent. Nor does the fact that William Finck uses his own name prove that he is not a smooth-talking informant. Hundreds of people invent internet handles, in order to avoid putting their real names on the net. As a cunning, street-wise cop, William Finck knows exactly what he is doing. So do most of his followers; but they stick with him because of his doctrine of hatred towards non-Whites, which is something they love to hear. This is the real issue; and in order to avoid dealing with the real issue, WF has engaged in a calculated smear campaign against an innocent Israelite.

My use of a penname alias is no more illegitimate than when Bryan uses the name of *Swordbrethern*. I don't see Bill attacking Bryan for ever using an alias. Why the DOUBLE STANDARD, Bill? Bryan was desperately trying to keep his real name a secret, so that the Zoggites couldn't find out where he lives. Also, he was job-hunting; and public knowledge of his Identity beliefs would dash his hopes for a good-paying job. In all the time that Bryan and I did radio shows, I never once betrayed his secret. If it's true that using an alias is proof of wrongdoing, then Bill Finck has a lot more people to make up stories about. At least I didn't choose a name like FINK!!!

Personal to WF: William Finck, I HAVE DONE YOU NO WRONG. And you know it.

# William Finck's Duplicity and Guile

"Blessed is the man to whom Yahweh imputes not iniquity, and in whose spirit there is no guile."
- Psalm 32:2. "Be ye therefore wise as serpents, yet guileless as doves." – Matt. 10:16.

One of BF's websites is <a href="http://plymouthis.com/">http://plymouthis.com/</a> Apparently, he either designed this site for someone else, or it is his site, designed to attract customers for his web designer/programmer business. Nowhere on this site is there any indication of Bill's theological or political views. Bill, I have a question for you. "WHAT ARE YOU TRYING TO HIDE, WILLIAM FINCK?"

Are you afraid that any potential customers might be driven away, if they knew you were a racist, Jew-bashing, faggot-bashing bigot, nigger-hating neo-Nazi? Those patriots who wear their racism on their sleeves make instant enemies and drive friends, family and BUSINESS away, as William Finck well knows. Bill, why don't you advertise your racist theology on your business card? Don't worry, Bill. I won't tell them. I don't engage in smear campaigns. You know I would never sink to the level of driving your customers away, thus affecting your livelihood.

William Finck has tried to parlay my alias into some sort of conspiracy against the White Race. The reality is very simple. In order to avoid confrontations with such ZOG groups as the ARA, I have created a dual identity: one for the public and one for my Identity teachings. William Finck is very much aware of my troubles with the ARA, as he personally witnessed their

attempted attack on our group in Binghamton NY on June 22, 2009. On that day, the ARA (Anti-Racist Action, a violent Jew-communist front group that operates in larger colleges) discovered the location of our meeting place. They called the New York Times and had that Jewish "newspaper" threaten the Veterans Hall where our meeting was scheduled. The VFW official caved in and we were evicted. Ironically, he handed us the eviction notice while we were standing in front the wall plaque dedicated to that organization's determination to defend "freedom of speech." Just as we were exiting the building, a crowd of 15 to 20 ARA marched in front of the building, chanting things like "Eli James is a racist, neo-Nazi."

There were only five of us there, the purpose of which was to broadcast our Paul Seminar on Talkshoe Radio. The VFW Hall had promised us that there would be either Wi-Fi or an internet connection for us to use, so that we could broadcast live. Despite this promise, neither of those options were available, so our hope of a live show was gone. Then one of the staff members walked into the room with the quotation from the New York Times, accusing us of being "anti-Semites" and informing us that our meeting was being cancelled. Looking out from the second floor window, we could see over a tall hedgerow, from where the protesters were approaching the building in the rain. At this point, we all agreed that it was time to pack up our equipment and leave.

Heading downstairs, we headed for the front door, but there was a film crew interviewing a bunch of veteran bikers, who were being interviewed, live, on the front porch by a local TV camera crew. The protestors immediately mistook these veteran bikers for the "anti-semites," and charged the front porch. At this point, taking advantage of the confusion, we decided to leave by the side entrance to the parking lot, and we quietly got into our vehicles and sped off, having agreed to rendezvous a few blocks away.

This was William Finck's introduction to my enemies, the ARA. So, for him to ask the question, "What are you trying to hide, Eli James?" I can only ask the question, "Where were you on June 22, 2009, William Finck?" What more proof do you need that I have every right to keep my enemies off my track? To avoid such confrontations with the agents of ZOG, and to have some semblance of a normal life, I had long before assumed a dual identity, around 1985, while I was writing my book, the Great Impersonation. That was the smartest thing I ever did, as it has enabled me to live in peace while surrounded by atheists, Democrats, Jews, and liberals. But it has not protected me from traitors within our own ranks.

There's a reason why the Ku Klux Klan refers to itself as "*The Invisible Empire*." Since the Binghamton confrontation, I have had many close calls with the ARA, who have known for a long time where our local congregation meets on Sundays. Fortunately, they have never been able to locate my home; but now, William Finck, the "true patriot," has done them a huge favor by publishing my home address on his website. This is a most dastardly, malicious stab in the back by WF; because he fully knows that I am not a Jew; and he fully knows that I am not a "universalist." It is very clear to me that Wlliam Finck wants the ARA, or some other wacko on the Judeo-communist side, to harm me and my family. Such an unconscionable act is unforgiveable, unless such act never occurs. But if it happens, traitor Finck, the killer cop, will bear full responsibility. Never in the history of CI has any member of our community published the home address of a CI elder. This is positively the most egregious, sinister act of personal attack that Christian Identity has ever witnessed. This is proof of Finck's unfitness to call himself "Identity," whatever his birth name is.

<u>If William Finck can hide his politics and theology from HIS customers, then I can do likewise with mine</u>. The only difference between his situation and mine is that I have an already

established clientele. And this is what has necessitated my use of an alias, as I would lose ninety percent of my customer base, if all my clients knew of my patriotic activites! So, again, Bill, I ask you, "WHAT ARE YOU TRYING TO HIDE?" Don't you advertise your theology and politics on your business card? If not, WHY NOT?

So, it's OK for Bill to hide his theology from his potential customers, but it's wrong for me to do so? I don't think so, folks. That's duplicity and guile. It's A-OK for Bill to hide from us the true nature of his involvement in the Ortega killing, but Eli James becomes a "Jew" for using an alias? Luke 12:1 covers this scenario: "Beware the leaven of the Pharisees, which is hypocrisy."

Then said Judas to the Pharisees, "There he is."

### **Local Confrontations With the ARA**

We have had many close calls with the ARA. On one occasion, we nearly had a brawl in front of the restaurant, but we outnumbered the ARA about five to one that day. There were only four of them. A female member of their group snuck toward our meeting room and started to take pictures of us through the doorway, with her camera phone. One of our guys spotted her and chased her out of the restaurant. Later that week, one of our group, a teenage Polish skinhead, discovered that his photograph was being circulated in the school halls, with the words, "anti-Semite," "Skinhead" and "Nazi" written on the pictures. This incident was very embarrassing for his parents.

This is what happens when you are in the front lines of the Resistance.

Since the Binghamton event, our group has had repeated confrontations with the ARA. At a downtown Chicago rally last summer, two members of my congregation, Tim and Matt, were attacked by the ARA, who charged at them with swinging chains. They defended themselves with knives. One of the ARA guys got seriously cut, so Tim and Matt got arrested for defending themselves with knives. The blades of the knives were half an inch beyond the legal limit for a "pocket knife," so they did overnight jail time and had to hire a lawyer to minimize the fines. The ARA thugs were **not** prosecuted.

At an anti-gay rally in Wisconsin, sponsored by the NSM, the organizers had the tires on their vehicle slashed. The NSM guard, who was supposed to watch the vehicles, had fallen asleep on the job, apparently because of his long overnight drive to the event. He heard the tires pop and the air hissing out of them, but the two ARA members ran away, right past the parking lot security guard, who did nothing to stop them!!

Last April, the ARA set off a smoke bomb in the men's room of our meeting hall. The fire department ordered us all out of the building, putting an end to the event. Smoke bombs are high heat incendiary devices, that can easily set fire to flammable materials. We were lucky that the bomb was detected early.

The organizer of that event, Arthur Jones, who is now running for Congress [ <a href="www.artjonesforcongress.com">www.artjonesforcongress.com</a>], has had many run-ins with the ARA. Because he is a well-known White Nationalist, the ARA has had a number of demonstrations in front of his house, doing damage to his property and threatening to do violence to himself and his wife. A few days after the smoke bomb incident, he had his automobile sabotaged. His wife was driving the vehicle on the expressway, when the brakes gave out. Fortunately, there was not much traffic and she was able to slow the car down without getting into an accident. Later, the mechanic

showed her where the brake lining was cut into by a hacksaw. The vehicle was slowly losing brake fluid. She could have been seriously injured. Shades of Cindy Steele!!!

This is what happens when you are in the front line of the Resistance. This is why many of our people use aliases and take great pains to prevent the enemy from knowing where we live. And William Finck, the street-savvy killer cop, asks, <u>in feigned ignorance</u>, "What are you hiding, Eli?" Bill Finck, nobody ever suspected you of being stupid.

This is why, way back in 1985, I started using the penname, Eli James, for my upcoming book, The Great Impersonation, How the Anti-Christ Has Deceived the Whole World. Shortly after I published this book, I established the publishing company under that name. This is all legitimate business, folks. There is nothing sinister about it, which is more than I can say for Finckahiser. I knew that publication of this book would make me a lot of enemies in the liberal, Jewish, communist subculture of America; and Chicago is such a hotbed: Saul Alinsky, Hilary Clinton, Barack Obama, Rahm Emanuel, etc. I started working on the book in 1980, collecting the relevant Identity literature. The actual writing began in 1982, as I had decided that I had enough documentation to proceed. The book was finally ready in 2003, when I self-published and started going on internet radio to inform White people about Two-Seedline Christian Identity.

FACT: Everyone who has read this book has proclaimed it to be the most thorough explanation of the Jewish impersonation of True Israel that anyone has ever written. Would a Jew write a book exposing his own people for the devils that they are? Benjamin Freedman is the only Jew I know of who has ever revealed the fact that Jesus was not a Jew. He also revealed the non-Israelite, Khazar origin of most Jews. Organized Jewry has hated him and shunned him for his revelations. But he was a millionaire and he could afford bodyguards. I do not have that luxury.

FACT: My websites, <a href="www.anglo-saxonisrael.com">www.killthebank.net</a> contain more information about Jewish treachery against the White Race than any other source on the net. No other author, besides yours truly, has so thoroughly explained how the Edomites of Idumea contrived to usurp the Kingdom of Judah during the days of Antipater and Herod, and how this group of Canaanite/Edomite Judeans became the scribes and Pharisees of Scripture. My research has identified the exact year in which King John Hyrcanus first began the anti-Scriptural practice of circumcising non-Israelite Idumeans: 121 BC. I receive constant emails and letters of appreciation for my clear, concise explanations of Jewish perfidy. <a href="And I do this without inciting hatred or violence">And I do this without inciting hatred or violence</a>. My message has always been: Here are the facts, and get ready for the Judgment Day, when Yahshua will return with His angels to destroy the Synagogue of Satan.

FACT: It is precisely because my ministry is so effective that I have incurred the wrath of ZOG; but they cannot attack me openly, because I have no criminal record; and they cannot afford the publicity that a direct attack upon me would generate. Therefore, they must proceed with sneak attacks, like the insidious attack that William Finck is foisting upon me and my family at this moment.

FACT: No other Bible scholar, with the possible exception of Clifton Emahiser, has revealed the detailed, continuous historical record of Jewish treachery against the White Race as I have, from Genesis 3:15 down to the present moment. Yet, Bill Finck calls me a "Jew." Why? The Jews have spent trillions of dollars rewriting history in order to deceive Christians into believing their false accounts of Scripture and their false accounts of history. My book and my websites calmly and clearly explain how the Jews have accomplished all of this historical deceit. Yet, Bill Finck, still accuses me a being a Jew. Why?

FACT: No other human being, living or dead, has revealed more about the sinister operations of the international banskters than Eli James. Would a Jew reveal these things about his own people? Would Al Capone put out a list of those who are part of his organization? Remember what Jesus said: "A kingdom divided against itself cannot stand." I DEMAND that William Finck provide his evidence that I am a "Jew." He cannot do this, because there is none. It is a total violation of Yahweh's laws to make an accusation without evidence. His deliberate smear campaign is aimed at those who are ignorant of my work; and they believe his lies, because they care little for Identity or for Yahshua Messiah. For most of them, His Name is not even on their lips. They are easy prey for Finck's Jewish smear campaign. They have itching ears for the likes of Hal Turner, who fooled them for many years, preaching violence and hatred against the Jews, while secretly entrapping White Nationalists who were gullible enough to fall for his hateful rhetoric. As I have repeatedly stated, "Anyone who preaches violence must be considered to be an informant." William Finck is no exception to this statement. His Extermination Thesis is nothing but a subtle form of preaching violence, as it justifies the killing of non-Whites, who are redefined by Finckahiser as "hybrids of the fallen angels." The Jew's favorite tactic is to send in agents masquerading as one of us. The ADL just loves it when violent rhetoric comes from our number. It makes their anti-Identity propaganda appear to be accurate.

The **Christogenea New Testament** is a very impressive calling card; but Finck's violations of Yahweh's laws demonstrate that he is a reprobate. It's amazing that someone who has done such a good job of translating the New Testament has such a poor comprehension of the meaning of those words. The leather-bound version is even more impressive, but it is a mere show, as, for someone who knows the New Testament as well as he does, he demonstrates a unique ability to avoid practicing the precepts contained therein.

"You must examine yourselves. Truly, do you not yourselves observe that Yahshua Christ is among you, <u>unless somehow you are spurious?</u>" - II Cor. 13:5, Finck trans.

For nearly two years, William Finck was my webmaster, at <a href="www.anglo-saxonisrael.com">www.anglo-saxonisrael.com</a>. For two and one half years, Bill Finck and I co-hosted numerous shows about the Bible, explaining how the Bible is exclusively about the Aryan Israelites. <a href="In that 2.5 years, William\_Finck never once intimated that I was anything but a White Two-Seedliner">Why the sudden change? Having posted most of the articles on my website, Bill Finck is intimately familiar with my work. During that time, he never once complained about me being a "universalist" or a "Jew." I even defended Bill against the attacks by Martin Lindstedt and Brian Akira. Everyone who has followed us on internet radio knows that this is the true record. <a href="This is how William\_Finck repays my actions in his defense!">This is how William\_Finck repays my actions in his defense!</a>!! Very Jewish!

The fact is that all of Bill Finck's accusations against me are SPURIOUS, except one. Yes, I have been using an alias; but there is no law against using an alias; and the fact that I do proves nothing. Finck has dumped a truckload of bovine excrement upon my head, an Everest of lies upon a molehill of fact.

### The Hidden Agenda Becomes Apparent

"Woe to the rebellious children, says Yahweh, that take counsel, but not of Me; and that cover with a covering, but not of My Spirit, that they may add sin to sin... That this is a rebellious people, lying children, children that will not hear the law of Yahweh: Which say to the seers, See

not; and to the prophets, Prophesy unto us not right things, <u>speak to us flattering things</u>, <u>prophesy deceits</u>." – Isa. 30:1, 10.

About the summer of 2010, Clifton Emahiser started ridiculing my position on Ron Wyatt and the Holy Blood, calling me a "liar" and a "fool" for taking Ron Wyatt seriously. Since Bill is Clifton's protégé, I waited to see where Bill stood on this issue. Then Clifton came out with his "Identifying the Beast of the Field" series, in which he made seriously flawed arguments concerning the supposed hybridity of the non-White races. At first, I had no objection to the thesis, but when I read Clifton's arguments, I wrote him a letter stating that his arguments in this area were not up to his usual standards. CI has always been the target of ridicule, therefore, we have to meticulously document our history and theology, so that we can put our critics to shame in open debate. Clifton's arguments in that series are weak and forced. In particular, his argument that non-Whites could not have been created by Yahweh because they were "not good" was purely subjective. This was not scholarship. This was dogma. Then, he tried to redefine the word CHAY to mean exclusively "wild animal," which is a blatant falsehood. When I challenged him to come up with better arguments, his response was "This means war." Ifound this response to be incredibly hostile and disrespectful to a fellow Israelite. I told Clifton that he was "barking up the wrong tree" and that I was going to prove his thesis to be erroneous.

From Clifton's arguments, I wrote "Beast of the Field," explaining why the entire thesis rests on shifting sands of unscientific and un-Scriptural speculations. My dispute with Clifton forced Bill to declare himself. Bill chimed in with his denial of the Day of Rest in Gen. 2. At this point, I realized that I had a two-horned bull aimed at me. So I took a stand against their Hybridity/Recapitulation thesis. It was at this point that the slanders against me began. I have not changed my theology at all. On the contrary, William Finck suddenly became a boisterous proponent of an idea which had never before been preached in Identity, two-seedline or otherwise.

I realize now that Bill and Clifton were already forming a cult-like coalition of followers, whose vitriol was increasingly aimed at me, because I did not share some of Finckahiser's opinions. The fact that I am a two-seedliner means that our opinions converge about 95% of the time, if not more. But it's the 5% that the cult of hatred dwells upon, never giving me credit for anything that I teach. This is what happens when you join a hate cult. Hatred is their reason for being.

"But in my adversity they rejoiced, and gathered themselves together: yea, the abjects gathered themselves together against me, and I knew it not; they did tear me, and ceased not with hypocritical mockers in feasts, they gnashed upon me with their teeth." - Psalm 35:15-16.

#### William Finck's Violations of Yahweh's Laws

Woe to them who devise iniquity and work evil upon their beds! When the morning is light, they practice it, because it is in the power of their hand. And they covet fields, and take them by violence; and houses, and take them away: so they oppress a man and his house, even a man and his heritage. – Micah 2:1-2. {Counts 8, 9 and 10}

In addition to the counts that have already enumerated, William Fincks's violations of Yahweh's laws, during this smear campaign, are beyond numerous. Recently, William Finck issued an ultimatum to people, saying "It's either me or Eli." I will second that. In this ultimatum, he

imitates the Jews again. We all know that the American Jewish community is at war. It has declared war on everybody and every organization daring to criticize Israel, no matter how justified this criticism is. Likewise, Finckahiser has declared war against those who do not relish their theology. Rather than engage dissidents in scholarly debate, they resort to insults and intimidation. No debate necessary! You are either for us or against us. Very Jewish!

Taking Finck's suggestion, I declare that you **should** choose between the carpenter from Chicago and the killer cop from New York. The difference between the two is quite stark. The carpenter guy advocates truth, compassion, brotherly love, and racial separation. The killer cop advocates the genocide of all non-Whites. And he will smear any White who opposes him. (Finck's version of "brotherly love.") Like the Talmudic rabbis, the killer cop twists the words of the Holy Scriptures, *putting words in Yahweh's mouth*, to the effect that all non-Whites become mongrels, like the Jews. Not only has William Finck NOT PROVEN that assertion, he has not proven that I am a Jew or a universalist. Rather, he has played games with words and concocted false arguments and put a clever spin on our true relationship, as if I have somehow betrayed him. Only one of us follows the commandments of Yahweh. So, choose wisely.

"Whosoever is angry at his brother without a cause shall be in danger of the judgment: and whosoever shall say to his brother Raca [meaning, "empty, vain, stupid"] shall be in danger of the council; but whosoever shall say, You fool, shall be in danger of hell fire." - Matt. 5:22. Behind my back, Finck and Emahiser have been calling me such names, ever since I published the Ron Wyatt material. This is un-Christian. William Finck has been violating these provisions of the Gospel of Matthew quite openly, and with increasing frequency, for his entire tenure as an ex-felon Bible scholar. At first, it started out with minor outbursts, by using the technique of name-calling against the Paul-bashers. Then, he graduated to ridicule and censorship of those who disagreed with any of his doctrine, especially after getting his own Talkshoe and Teamspeak shows.

Instead of treating his Identity brethren with love and compassion, his habit is to chide and insult. In short, William Finck has failed to demonstrate a Christian attitude. And his actions have been an embarrassment to the Christian Identity movement. It is not enough to talk the talk. You have to walk the walk. And in the latter department, William Finck has failed the test of Christian morality.

Isaiah 29:20-21: "For the terrible one is brought to nought, and the scorner is consumed, and <u>all that watch for iniquity are cut off</u>: **That make a man an offender for a word**, and lay a snare for him that reproveth in the gate, and turn aside the just for a thing of nought."

Making mountains out of molehills is their specialty. William Finck and his hatchet men have been scouring my websites and my radio interviews for signs of "universalism," just like the Pharisees who sought to accuse Yahshua for a single word. They follow me around like vultures, seeking to accuse me of violations of *their own doctrine*, or to see if I have ever uttered a kind word about a non-White. And then they even lie about that, as I have NEVER stated that non-Whites can be "saved." NEVER, and William Finck knows it. All of Finckahiser's accusations are baseless, except for one. Yes, I admit it, I use aliases. But I do not violate Yahweh's laws. I take Yahweh's laws much more seriously than Messers Finck and Emahiser.

My answer to your false accusations, Diablo Finck, is Psalm 94:

"Yahweh, how long shall the wicked, how long shall the wicked triumph? How long shall they utter and speak hard things? And all the workers of iniquity boast themselves? They break in pieces your people, O Yahweh, and afflict Your heritage... Yet they say, 'Yahweh shall not see, neither shall the God of Jacob regard it.' Understand, you brutish among the people: and you

fools, when will you be wise?..Who will rise up for me against the evildoers? Or who will stand up for me against the workers of iniquity? Unless Yahweh had been my help, my soul had almost dwelled in silence...SHALL THE THRONE OF INIQUITY HAVE FELLOWSHIP WITH YOU, WHICH FRAMES MISCHIEF BY A LAW?"

Finckahiser has created a fictitious law: that all non-Whites are deserving of death. My God! What blasphemy!!! And in order to promote this phony baloney theology, they have smeared anyone who stands in their way. How Jewish!! Finckahiser, you have done the Pharisees proud!

Far from being an example of Christian jurisprudence, William Finck has played the juicy role of petty dictator, while throwing childish tantrums when he doesn't get his way. However, being a street-wise cop and the author of the **Christogenea New Testament**, there is no way that he can plead ignorance about his tactics. He is doing these things in full cognizance of their iniquity. William Finck is a fully conscious reprobate, and he knows it. And I know it.

"For men shall be lovers of their own selves, covetous, boasters, proud, blasphemers, disobedient to parents, unthankful, unholy...FALSE ACCUSERS, incontinent, fierce, <u>despisers of those that are good</u>...having a form of godliness, but denying the power thereof: FROM SUCH TURN AWAY." - 2 Tim. 3:1-5.

This is why I turned away from Finck and Emahiser, after they called me a "liar" and a "heretic" on my own talk show. Unless you repent of your false accusations against me, and unless you remove all of your blasphemous videos and articles about me from your various websites, Yahweh will surely judge you, according to your own designs. Repent now, before it's too late.

The amazing thing is that BF actually thinks he can get away with this ritual defamation. Yahshua will have something to say about this. See Matt. 7:15-23.

### Finck's Fairy Tales

"Be ye therefore wise as serpents, yet harmless [guileless] as doves." – Matt. 10:16.

Ever since I first read this passage of Scripture, it became my guide, my personal Golden Rule. We are instructed to be guileless, to have no evil intentions in whatever we do. Since Yahweh repeatedly states that he will protect his sons and daughters who obey His laws, we are to put our full faith and trust in Him. Those who do not follow Yahweh's laws are either reprobates or lacking in faith. Because Finck and Emahiser have opted to violate Yahweh's laws in their smear campaign against me, they have proven themselves to be both.

"Destroy, O Yahweh, and confuse their tongues: for I have seen violence and strife in the city. Day and night they go about it upon the walls thereof: mischief also and sorrow are in the midst of it. Wickedness is in the midst thereof: deceit and guile depart not from their streets. For it was not an enemy that reproached me; then I could have endured it: neither was it he that hated me that did magnify himself against me; then I would have hidden myself from him. BUT IT WAS YOU, A MAN MY EQUAL, MY GUIDE AND MY ACQUAINTANCE. We took sweet counsel together, and walked to the house of God in company. Let death seize upon them, and let them go down quick into hell: for wickedness is in their dwellings, and among them. As for me, I will call upon Elohim; and Yahweh shall save me." - Psalm 55:9-13.

David, I know exactly how you feel, being betrayed by a peer, who I once thought was a friend.

Jesus answered and said, 'Behold an Israelite, in whom there is no guile.' – John 1:47. Gosh, it's hard to find Israelites today in whom there is no guile!!!! Fortunately, we have the Holy Scriptures to guide us in our search.

#### A Baker's Dozen

The appearance of Finckahiser's Hybridity Thesis has proven to provide a number of firsts in the Identity Movement. And none of these firsts speak well of either man.

### NEVER BEFORE, IN THE HISTORY OF CHRISTIAN IDENTITY, HAS

- Any CI minister publicly criticized another CI minister.
- Any CI minister publicly chastised or ridiculed individual believers.
- Any CI minister proclaimed that those who do not believe as he believes are "heretics" or "universalists."
- Any CI minister engaged in an ongoing smear campaign against another CI minister.
- Any CI minister called another one a "liar."
- Any CI minister produced videos depicting other CI ministers as Arabs or Jews.
- Any CI minister published the home addresses of other ministers.
- Any CI minister repeatedly lied about another minister.
- Any CI minister tried to redefine the non-White races as hybrids of the fallen angels.
- Any CI minister advocated the extermination of the non-White races.
- Any CI minister used deliberately false definitions of Hebrew and Greek words in order to deceive the flock.
- Any CI minister created a cult following for the deliberate purpose of engendering hatred towards another minister.

# Last, but not least,

- William Finck is the FIRST PERSON EVER to use internet proxies (front groups), in order smear an individual.

An example of this last, very Jewish tactic is the infamous "*Eli James is a Universalist*" video that appears at under the "*Threats to Identity*" heading on one of his proxy websites. Finck claims that he is not the one who produced the video, but it is certainly on one of his proxy sites.

Yet, Finck will say of this site, "It's not my site." But he designed it, built it and posts the items on it, just as he did with my site for over two years. But that's like Frank Lloyd Wright saying, "It's not my home," after someone purchased one of his designs. I'm not nearly the computer whiz that Bill is, but I know my way around the net; and I can tell when someone is using the internet to do a hatchet job on me.

One final category of offenses committed by William Finck is his use of foul language. I don't know if he has dropped the F-bomb on the air, but he uses it in his emails.

Here is what Paul has to say about the use of foul language. "You must not let any corrupt word go out of your mouth, but if anything good is of use for building, that would give delight to those listening. Also, do not vex the Holy Spirit of Yahweh in which you have been approved for the day of redemption. All bitterness, and indignation, and wrath, and crying, and blasphemy must be removed from you, along with all malice. Now, you must be kind to one another, good-hearted, forgiving with yourselves; just as Yahweh also, in Christ, has forgiven you." - Ephesians 4:29-32, Finck trans.

<u>Great translation, Bill.</u> When are you going to observe the principles that you have so eloquently recorded?

Here is what Peter has to say: "And the tongue is a fire, a world of iniquity: so is the tongue amongst our members, that it defileth the whole body, and setteth on fire the course of nature, and it is set on fire of hell...Therewith we bless God, even the Father: and therewith we curse men, which are made after the similitude of God. Out of the same mouth proceedeth blessing and cursing: my brethren, these things ought not so to be." – James 3:6-10.

#### Who Is William Finck?

One of the worst offenses among the CI brethren is their constant rantings and ravings AGAINST EACH OTHER. As in the White Nationalist movement in general, most of this infighting is due to self-righteousness and honest disputes over doctrine. But the enemy just loves it when we fight amongst ourselves. And ZOG has had no shortage of infiltraitors with whom it causes dissensions over doctrines and leaders. One of our biggest downfalls is gullibility and short-sightedness. Instead of following the principle, of "Come, let us reason together," they act like clowns. Adam, you still haven't learned. You are still overly stiffnecked, to the point of being naked.

"They honoreth me with their lips, but their heart is far from Me." - Mark 7:6.

Cursing, ridiculing and slandering the Brethren is a no-no, William Finck. Will you ever learn the principles of Christian Identity?

"Blessed are those who hear the Word of God and obey it." – Luke 11:28.

In this theater of defending myself, I am at a distinct disadvantage. Finck can sit at his computer desk 24/7, composing phony stories about me, writing blogs on numerous WN sites, while his mother feeds him and houses him. As Nietszche said, "*Idleness is the beginning of all psychology*." While he has all the time in the world to concoct false accusations against me, I still have to work for a living, answer prisoners' mail and appear at White Nationalist gatherings around the country. I do this at my own expense and at great risk to house and home. I also owe a debt of gratitude to those who have financially supported my ministry. These donations enable me to spend more time on Identity and less time on the job.

Despite this clear record of service to my People, Israel, William Finck is doing his damnedest to destroy my ministry. Indeed, he is a busy bee!!! He has the zeal of a provocateur; and he apparently relishes what he is doing! This psycho cop knows exactly what is doing. The amazing thing is that he thinks he can get away with it!!!!! It is only a question of time before reality sets in for his followers, as his tactics betray his mind and heart. Yahshua told us how to recognize an evildoer: "By their fruits shall you know them." An evil heart begets evil fruit. The above list of evil fruits is enough to convict anybody, let alone a killer cop.

All of the above offenses have been employed by Finck and Emahiser in their attempts to silence their critics - another Jewish tactic. From this list, which cannot be denied by Bill and Clifton, it is quite obvious that this dynamic duo of death has an agenda against the well-established theology of Christian Identity. There are only two possibilities for this agenda:

- 1.) Out of sheer gall and guile, Finckahiser is determined to take over the Identity Movement, in order to turn it into just another racial hatred group. **Or**
- 2.) There is a more sinister agenda. It was Brian Akira, who first suggested that William Finck was a collaborator.

When Mr. Akira first made that suggestion, I wrote a rebuttal defending both myself, William Finck, and Identity in general. After I published my rebuttal, I remember asking Bill to take up the fight against Mr. Akira, especially on those points where Mr. Akira made direct reference to Bill's positions. [Link: <a href="http://anglo-saxonisrael.com/site/node/366">http://anglo-saxonisrael.com/site/node/366</a>] I was rather surprised at Bill's lack of desire to respond. Here is William Finck, the pit bull of Christian <u>Identity</u>, <u>backing down from a fight</u>. Maybe he was too busy working on the Hybridity Thesis? I did not give it a second thought until I had another opportunity to examine Mr. Akira's charges, well after Finck stabbed me in the back, in January 2011. I revisited the articles that Akira posted about Bill Finck's arrest and conviction in the death of Arnaldo Ortega. These articles were sketchy and provided little detail. I had literally put them out of my mind. When I visited Bill at his home in Norwich, New York, in the fall of 2010, I asked him about the circumstances of his arrest and imprisonment. He told me what he had told many others, namely that he had nothing to do with the beating, that he should have served no more than a few months, but that he was "punished" by the prosecution for refusing to testify against his fellow prison guards. I had no reason to disbelieve his story. I have a mailing list of 200 White prisoners, some of whom have been incarcerated for murder. Some of them have been railroaded, some not.

Since then I have learned that he has told this story to many people. <u>However, that story</u> is a lie.

The truth is that William Finck was personally involved in the death of Mr. Ortega, although he did not initiate the beating. But Bill's involvement made the beating become fatal; and Bill wound up plea-bargaining down to a lesser charge, "Violating the Civil Rights" of the victim. His conviction on this charge fails to identify the severity of the crime, which resulted in Mr. Ortega's death. The presiding judge, Judge John Lifland, declared that Finck's involvement amounted to "second-degree murder." The Star-Ledger article which provides the grisly details is reproduced below.

Had William Finck not begun his smear campaign against me, I would never have had any reason to reinvestigate Brian Akira's charges against William Finck. I was perfectly willing to let Bill go his way while I went mine. In the last year, I was occupied by scripting, shooting and editing the *Merchants of Babylon* video, which required a lot of on-location sites and a couple of months of post-production work. This video is now available at <a href="https://www.killthebank.net">www.killthebank.net</a>. Watch that video and ask yourself, "Would a Jew reveal all of this information about the Jewish religion, with its criminality, genocide, and Satan-worship?" Only Eustace Mullins has revealed more about Jewish criminality than I have. He has also been smeared, the most common smear is that he was a "homosexual." How many homos have written books exposing the Rothschild banking syndicate?

I also wrote three scholarly articles in this time. The first was "The Parable of Ruth," which explains the fact that the Book of Ruth casts Ruth as a type for Aryan Israel, and Boaz as a type of Christ, at both the first and second advents. The second article was "Salvation and the Second Coming," which shows, from Hebrew and Greek word studies, that the word 'salvation' applies only to Aryan Israel. The third was "Genesis 1 & 2," which provides the Hebrew linguistics, chronology, archeology and science behind my analysis of those two chapters of Genesis, showing how the original language conforms very well to old earth creationism (not the 7 literal days version called new-earth creationism) and to natural science. While I was doing these things, Finck and Emahiser were viciously attacking everything I have ever said or done.

Since I don't have the time to match Finck's continuous output of contemptuous rhetoric, my only option is to defend myself against his lies. Since Finck continues to betray others, besides myself, it is only a question of time, as to when his true agenda will be made public.

At this point, it is almost irrelevant whether Finck is an agent or not. The damage that he and Emahiser have done within our community is enough to convict them of evil deeds, if not intentions. Although I have been the primary target of their feigned outrage, everyone who has ever challenged their assertions has received similar treatment. This is totally unacceptable from any Christian. Their guile-filled approach to dissenters is totally unprecedented in the history of CI. And anyone who approves of their tactics is equally suspect.

CI has always been based on the concept of racial segregation and brotherly love for our own race. But Finckahiser has sunk to the level of hating their own Brethren. This is unacceptable. Also, this dynamic duo of death are the first ones to introduce an element of racial hatred towards the other races. Indeed, Yahweh declares His Hatred towards the Edomites and Canaanites. But their spurious attempt to redefine the other races as mongrels puts all non-Whites in the category of those whom Yahweh hates. This doctrine is especially self-serving for William Finck. It is modern Pharisaism, disguised as "Identity."

This brings me again to the question, "What are YOU HIDING, William Finck?" Why did you hide from us your personal responsibility for the death of Arnaldo Ortega? The answer is obvious. Such a person would have no credibility coming out of prison. I can see the headline: "Cop Who Murdered Mexican Claims that God Hates Blacks, Orientals and Mexicans." I can see Mr. and Mrs. White Christian having coffee. "Can you believe this, Myrtle? Some guy named William Finck, who was convicted of beating anon-White to death, claims that God hates all non-Whites. He must be one of those evil neo-Nazi, Christian Identity types." And Finck says that I, Eli James, am the one giving Identity a "bad name." If it weren't so wicked, it would be funny!

FACT: William Finck used me to establish his credibility as a CI teacher; and then he stabbed me in the back, when he began to teach a doctrine that I knew was unsupported by either Scripture or science. Finck's further record of violating Yahweh's laws proves that he is NOT one of us. The REAL CHAMELEON resides in Norwich, New York. The fruit of Finckahiser has been to disrespect the brethren, to lord it over us, and to concoct the false idea that only Whites will survive the Judgment Day, based upon the unproven assumption that all non-Whites are hybrids of the fallen angels. This theory is pure garbage. For proof, just see Zechariah 14:10-21, where the End Time heathen nations are clearly depicted as still in existence and subject to our dominion – after the Judgment Day.

Mr. Chameleon, if you do not respect dissenting opinions, how can you expect anyone to respect yours? Like the Jews, you demand respect but fail to give it. Your duplicity and lawlessness will be your own undoing. By imitating the Jews, you flatter them as well.

### **And Then Along Came Nachash**

When Nachash seduced Eve, he told her "You shall NOT surely die." He cajoled her and flattered her, until she finally gave in and, not thinking that she was doing anything wrong. She was seduced by Nachash and gave birth to Cain, the first murderer. This is standard two-seedline doctrine, which no Jew has ever promoted to the public. This is what I have always taught; so, the idea that I am a Jew is quite absurd. No Jew would ever publicize such a doctrine. Although the Talmud contains references to Eve's sexual seduction, no rabbi ever quotes these passages

publicly, because they themselves know that they are of that very seedline!! Two-seedline totally undermines all Jewish claims to being the people of the Book. This is why the ADL and other Jewish groups do their utmost to suppress this doctrine. On the other hand, any doctrine which promotes violence against non-Whites is immediately jumped upon by the ADL and used by organized Jewry as a weapon against us. The Jews will immediately publish the activities of a guy like Hal Turner, and use his rhetoric to paint the whole White Patriot movement with a broad brush. When it was discovered that Hal Turner was a collaborator, the ADL became silent, because he was obviously working for them.

Here we are again. Nachash SAID TO Eve, "You don't have to worry about obeying any laws. You're a goddess! You're a queen! You're a babe! How can these beasts of the field ever have power over you?" Flattery will get you everywhere. Today, we have two individuals in our midst, who are advocating one of the slickest arguments ever conceived against non-Whites; but the REAL TARGET IS WHITE MEN. They want you to believe a lie. "Oh, no," say Finck and Emahiser, "It's not WE who hate non-Whites. IT'S YAHWEH WHO HATES ALL NON-WHITES." Putting words in Yahweh's mouth is a Talmudic specialty. As in the case of Adam and Eve, Finck and Emahiser have done a good job of fooling those who care not for Yahweh's laws. But those of us who obey His laws are not fooled. Their Hybridity Thesis is garbage theology; and it has no place in Christian Identity.

Today, in these last days, Nachash has reappeared in the guise of a pair of "Identity teachers," who whispered in Eve's ear, saying, "It's not enough for you to have glory. It's not enough for you to be immortal. It's not enough for you to have dominion over all of the living creatures [CHAY] on this entire planet. Eve, snuggle up real close now, get yourself real comfy with what I'm about to tell you. Listen to me, Eve [whisper, whisper, hint, hint, hiss, hiss], you MUST HATE THE OTHER RACES AS WELL, Yahweh Himself says so! [Cough! Cough! Sputter! Sputter!] You must hate even those who have done you no wrong. Even those who have blessed you! Only then will you have dominion." And this doctrine is being peddled by those who claim to be "superior." This doctrine is an ASSAULT upon Christian Identity, dressed up in theological garb, pitched to those who ignore Yahweh's laws.

Six thousand years after Eve was seduced by an act of sexual seduction, Nachash has reappeared in the form of the Messiah of Exterminationism! Adam and Eve, if you fall for this garbage theology, you will surely deserve to die the death of the gullible.

The Finckahiser doctrine is just the latest version of "White makes right," dressed up in Identity garb, and laced with dubious Scriptures, to flatter the gullible. This doctrine is diabolically clever. Compare: Dispensationalism teaches that all of the races were saved by Jesus at the Cross, two thousand years ago. And when He returns, we will have a mutlicultural love fest. In addition, the law has been abolished, therefore, there is no need to worry about Judgment. All you have to do is BELIEEEEEVE!!! "Glory, Halleluiah! We can do whatever we please and we still get into heaven." Likewise, the Finckahiser doctrine teaches that All Whites will be saved at the Judgment Day, no matter how badly they have betrayed their race. "Glory Halleluiah! We're all saved by the color of our skin!" Very seductive!!!! This is the gist of Finck's "All Israel will be saved" doctrine. But this would mean that even John Hagee, Joyce Meyer and Joel Osteen, not to mention ESAU, will get into the Kingdom. Would you want to live in place that had them in it?

According to Rabbi Finck, they will get rewarded for their betrayal of the White Race, just because they happen to be White! (This may just be wishful thinking on Bill's part.) [Listen to "All Israel shall Indeed Be Saved": http://christogenea.org/content/christogenea-forum-call-

<u>02-28-11-all-israel-shall-be-saved</u> Click on the play button near the upper left. You have to wait for the Irish jig to end.] I don't think so, folks! As I have already stated, "All Israel" is the expression for all twelve tribes being preserved forever, as tribes, not as individuals. In no way can this expression mean that every Israelite whoever lived, despite committing crimes against his own race, will be saved. For proof, <u>read John 15:1-10</u> and weep. There have been many race-traitors among us, who have not repented, such as Esau. We will all be judged, individually, according to our works. If you don't obey the Law, your branch gets tossed into the fire, even if you are an Israelite!!! Those of you who do not repent, I can already hear your cries of anguish!

If this isn't a diabolical sales pitch for phony salvation, I don't know what is!!! It's a carbon copy of antinomianism. Just replace the word *believer* with the word *White*, and you're saved!

Move over, Nachash, you've got competition!!! No one gets saved without total commitment to Jesus Christ and His laws. I have yet to see this commitment coming from the Finckahiser camp. What did He say? "If you love me, KEEP MY COMMANDMENTS." Bill Finck says, "Don't worry, you've got white skin." Is this not what Nachash said to Eve? "You don't have obey His law. You're already a divine being! What do you have to worry about? You're already White!" Bill's followers think they are ALREADY SAVED by the color of their skin. Talk about universalism, Aryan universalism!! From this perspective, Bill Finck is the Joel Osteen of racial salvation!!!

Satan, you are one really clever dude!! Last time around you fooled Eve. This time you're trying to fool Adam. Just as Nachash whispered sweet nothings into Eve's ear, William Finck is shouting gigantic flatteries at gullible White men, exploiting their justified fear and anxiety about the survival of their race. But it's theological deception, just as Satan's whispering to Eve was theological deception. Tell me, White Man, that you're not so stupid as to believe these lies!!!!!!

Now you can see why Bill Finck's ad hominem attacks against me are so furious. He cannot afford to have anyone challenging the legitimacy of his doctrine. His papal bull must not be challenged!! It's Satan's last seduction, before the Judgment Day! And by publishing my home address and phone number [disconnected, sorry!] on his website, he is hoping that some ARA thug will take the hint and do me harm! Wasn't that the Serpent's true intention? Sorry, Bill, your iniquity will come back upon you double!!!

This kind of theological rubbish is exactly what the ADL wants us to preach, so that they can reduce us to a bunch of mere racist bigots, fitting right in with their pre-packaged propaganda about us! This position is what makes the macho crowd within the WN movement look silly; and this type of rhetoric makes it so easy to turn off other Whites, who might otherwise be saved. Finck and Emahiser are doing the ADL a BIG FAVOR, by driving away exactly those Whites who need to hear the CI message.

### **Judaism In Disguise**

The Finckahiser contention that all White Israelites will enter the Kingdom, no matter how evil they have been, is, in essence, a form a universalism for Whites. The Judeos, like Joel Osteen and John Hagee, preach that "You are saved if you believe in Jesus." But today's Eve (Judeo-Christianity as practiced by Whites) is not the target of their deceptions. She has already been seduced. Finckahiser's target audience is the Angry White Male. It is all of the macho Adams out there, who see no solution to the race problem but the extermination of non-Whites.

For these White Nationalists attracted to Bill's purely racial supremacism, the bait is "All you have to do to be saved is to have white skin." Their response is, "Yeah, Preach it, Bill. Tell us what we want to hear!" John 15:1-10 completely refutes this doctrine of "salvation by race only." Read it and weep, White man. And because I have stood in the gap between their phony ideology and their target audience, Finck and Emahiser have decided to use every dirty trick in the book, trying to convince everyone that I am a "Jew," so that, by demeaning me in their eyes, they don't have to consider my arguments against their garbage theology. I know that the fobs don't read my essays. Their hateful emails to me prove it. This is the same tactic the Jews use to prevent people from reading **Mein Kampf** or Identity literature. "Don't listen to Adolf Hitler, he's a genocidal maniac." "Don't listen to Eli, He's a Jew!" Of course, both statements are as devious as they are untrue. The only difference is that these deceptive statements have different target audiences. Bill Finck, you are one clever dude! But you'll NEVER outwit Yahshua. He is keeping a record of your deceptions.

<u>This is Talmudic Judaism in disguise, reworked and repackaged for gullible Whites.</u> To quote a great prophet, "*Get thee behind me, Satan.*"

# **Something Is Rotten in Norwich**

Bill Finck will punch your ticket into the Kingdom. "It's EASY, folks. It's just a matter of DNA. Obedience to Yahweh's laws is NOT REQUIRED. Just be White!" You'll eventually be forgiven, if you're an Israelite. Says the Finck follower, "Hey! This is great! I can keep on smoking dope. I can fool around on my wife, or not bother to get married at all. I can kill non-Whites with impunity; and I'm saved!" This snake oil salesman is a ticket scalper, and he's selling tickets REAL CHEAP!!!!

Has Eve wised up yet? Has Adam wised up yet? The vast majority of Adam and Eve's descendants are still in the dark. They have no idea who they are or why they are. The Christian Identity message is the last wake-up call for the White Race, before the Judgment Day. You can listen to cheap flatteries, or you can put on the armor of Yahweh (obey His laws) and get yourself ready for the Kingdom. # APPENDIX A: Who Is William Finck?

William Finck lied to us about the extent of his involvement in the death of Arnaldo Ortega. He claimed that he was merely sitting at his desk when all of the brutality happened. Here is what really happened:

He was only 27 years old when he was brought to the old Hudson County Jail in Jersey City to await trial on a minor burglary charge.

But for Arnaldo Ortega, it was to become a sentence of death.

In the early morning hours of March 9, 1989, Ortega asked for headache medication. In response, he was dragged from his cell and subjected to a series of unprovoked beatings that left him bleeding, broken and pleading for help. Two days later, after slipping in and out of consciousness and calling for his mother, Ortega died from his injuries.

Yesterday, after a protracted journey through the criminal justice system, the two jail guards responsible for the fatal beating got their own punishment in Newark federal court prison sentences of 14 and 15 years without parole. For the family of the victim, it was a moment of quiet satisfaction.

"I know he's not going to come back to us," said the victim's brother, Louis Ortega, "but wherever he is, he sees that he got justice, too."

Outside the courtroom, Magdalene Negron, the victim's mother, searched for the words to describe her feelings at the conclusion of the federal civil-rights case against the guards. "I have waited for seven years for this justice," she said softly.

For the guards, David Dumers, 43, and William **Finck** cq, 35, who had been a sergeant at the time, the sentences mean that two men who so brutally abused their authority as prison officials will spend the next decade and a half as inmates themselves.

U.S. District Judge John Lifland ordered Dumers to serve 15 years and **Finck** imprisoned for 14 years.

A third prison guard, Thomas Murphy, 36, who pleaded guilty to failing to report the ongoing brutality, was sentenced to a far more lenient term of four months, although Lifland noted that if he had acted differently, "Mr. Ortega would be alive today."

Although both Dumers and **Finck** were sentenced for federal civil-rights violations, the judge branded the beating of Ortega a "cold-blooded" crime that amounted to second-degree **murder**, and said **Finck**'s comments during the attack added an "unusual level of depravity to an already depraved situation."

Neither Dumers, white-haired and dressed in a rumpled gray suit, nor **Finck**, the bearded and bespectacled father of five, made any comment to the court.

Finck had pleaded guilty to the crime, while Dumers was convicted at trial.

As pieced together from court testimony and government documents, Ortega had been in the jail for approximately five weeks when he began complaining of a severe headache and was taken to the Jersey City Medical Center, where he was given a prescription pain killer. Around midnight the following day, he asked a guard for his medication.

Ortega was beaten to death "because he had the temerity to request medical attention for a headache," Assistant U.S. Attorney Aidan O'Connor said in a report to the court.

According to O'Connor, the prison's deputy warden, Raymond Murray, told **Finck** to send corrections officers to handle the problem. (A federal jury deadlocked on civil rights charges against Murray in April.)

Dumers and Murphy, O'Connor said, then dragged Ortega out of his cell to an elevator. "This elevator ride," O'Connor said, "signaled the beginning of the end for Mr. Ortega." With his screams of "Don't beat me" echoing through the prison corridors, Ortega was brought to the basement. When the door opened, Ortega, still pleading, stumbled out and fell into a pile of mattresses.

At that point, Dumers smashed him in the head with his nightstick and brought him to the main receiving desk, where **Finck** ordered Ortega placed in the bullpen. Other guards subsequently told of hearing the sound of someone being struck, and Ortega, dressed only in a pair of shorts, was left shivering and beaten.

When Ortega complained of the cold and begged for a blanket, **Finck** allegedly responded: "No, let him freeze in there."

It was at that point, O'Connor said, that **Finck** and Dumers decided to "shut Ortega up." Court documents described in chilling detail what happened next. Carrying a 24- inch fiberglass baton, **Finck** ordered Murphy and another officer, Richard Maroldi, to stand watch as he and Dumers entered the bullpen.

**Finck** knocked Ortega onto a concrete bench and began pounding the victim's back with his nightstick "with all his power."

Dumers then punched Ortega in the throat, crushing his larynx.

As Ortega collapsed on the floor, choking and gasping for air, **Finck** kicked him in the chest, fracturing his sternum.

Leaving the battered victim gasping for breath, the two men walked out of the bullpen, calmly put the nightstick away, and went about their business for the remainder of the shift. Ortega, now only partially conscious, his body covered with welts and bruises, was transferred to another bullpen, where he begged another inmate to rub his head and cried for someone to "Call my mother, they beat me up."

When one of the other prison guards told **Finck** that Ortega needed to go to the hospital, **Finck** allegedly replied: "F him, let him die," and then warned the guard, "Keep your mouth shut or else."

Ortega was left without care for the entire day. It was only when another officer saw him that evening, lying on the floor writhing in pain, his lips caked with blood, that Ortega was ordered to the hospital, where he was diagnosed with a brain hemorrhage, a fractured sternum and a fractured larynx. He died March 11.

The suspects originally were indicted on state **murder** charges, but a series of legal problems plagued that case. Finally, the U.S. Attorney's Office and FBI moved ahead on the federal civil-right case against them.

Maroldi pleaded guilty to a related misconduct charge in Superior Court in Hudson County. Maroldi had walked away from the beating in disgust and later urged **Finck** to get medical help for Ortega.

# Appendix B: The Art of Ritual Defamation, Posted by Michael Santomauro

The elements of a Ritual Defamation are these:

In a ritual defamation the victim must have violated a particular taboo in some way, usually by expressing or identifying with a forbidden attitude, opinion or belief. It is not necessary that he "do" anything about it or undertake any particular course of action, only that he engage in some form of communication or expression.

The method of attack in a ritual defamation is to assail the character of the victim, and never to offer more than a perfunctory challenge to the particular attitudes, opinions or beliefs expressed or implied. Character assassination is its primary tool.

An important rule in ritual defamation is to avoid engaging in any kind of debate over the truthfulness or reasonableness of what has been expressed, only condemn it. To debate opens the issue up for examination and discussion of its merits, and to consider the evidence that may support it, which is just what the ritual defamer is trying to avoid. The primary goal of a ritual defamation is censorship and repression.

The victim is often somebody in the public eye - <u>someone who is vulnerable to public opinion</u> - although perhaps in a very modest way. It could be a schoolteacher, writer, businessman, minor official, or merely an outspoken citizen. <u>Visibility enhances vulnerability to ritual defamation</u>.

An attempt, often successful, is made to involve others in the defamation. In the case of a public official, other public officials will be urged to denounce the offender. In the case of a student, other students will be called upon, and so on.

In order for a ritual defamation to be effective, the victim must be dehumanized to the extent that he becomes identical with the offending attitude, opinion or belief, and in a manner which distorts it to the point where it appears at its most extreme. For example, a victim who is defamed as a "subversive" will be identified with the worst images of subversion, such as espionage, terrorism or treason. A victim defamed as a "pervert" will be identified with the worst images of perversion, including child molestation and rape. A victim defamed as a "racist" or "anti-Semitic" will be identified with the worst images of racism or anti-Semitism, such as lynchings or gas chambers.

Also to be successful, a ritual defamation must bring pressure and humiliation on the victim from every quarter, including family and friends. If the victim has school children, they may be taunted and ridiculed as a consequence of adverse publicity. If they are employed, they may be fired from their job. If the victim belongs to clubs or associations, other members may be urged to expel them.

Any explanation the victim may offer, including the claim of being misunderstood, is considered irrelevant. To claim truth as a defense for a politically incorrect value, opinion or belief is interpreted as defiance and only compounds the problem. Ritual defamation is often not necessarily an issue of being wrong or incorrect but rather of "insensitivity" and failing to observe social taboos.

An interesting aspect of ritual defamation as a practice is its universality. It is not specific to any value, opinion or belief or to any group or subculture. It may be used for or against any political, ethnic, national or religious group. It may, for example, by anti-Semites against Jews, or by Jews against anti-Semites; by rightists against leftists or by leftists against rightists, and so on.

The power of ritual defamation lies entirely in its capacity to intimidate and terrorize. It embraces some elements of primitive superstitious belief, as in a "curse" or "hex." It plays into the subconscious fear most people have of being abandoned or rejected by the tribe or by society and being cut off from social and psychological support systems.

The weakness of ritual defamation lies in its tendency toward overkill and in its obvious maliciousness. Occasionally a ritual defamation will fail because of poor planning and failure to correctly judge the vulnerability of the victim or because its viciousness inadvertently generates sympathy.

It's important to recognize and identify the patterns of a ritual defamation. Like all propaganda and disinformation campaigns it is accomplished primarily through the manipulation of words and symbols. <u>It is not used to persuade</u>, but to punish. Although it may

<u>have cognitive elements, its thrust is primarily emotional</u>. Ritual Defamation is used to hurt, to intimidate, to destroy, and to persecute, and to avoid the dialogue, debate and discussion upon which a free society depends. <u>On those grounds it must be opposed no matter who tries to justify</u> its use.

#### **Final Note**

William Finck's attempts to defame me will fail precisely because of the weakness of his arguments, the Jewishness of his tactics and the obsessive overkill of his method. By setting himself up as the Grand Inquistor of Identity, he is exposing himself for what he truly is: *an impostor*.

This detailed record of his duplicity and guile proves that William Finck honors Yahweh with his lips, but he denies the Father with his deceitful words and public violations of His laws.
