I, Det. Mike Barnett from the Newton County Sheriff's Office, upon my oath and under penalties of perjury, state as follows:

1. I have probable cause to believe that David W Milligan

2. The date of the criminal offense as definitely as I can state was on or about summer of 2010.
3. The place of the criminal offense as definitely as I can state was at, [REDACTED] Pineville, McDonald County, Missouri.
4. The facts supporting this belief are as follows:

I was contacted by Chief Deputy Chris Allison of the McDonald County Sheriff's Office. Chief Deputy Allison requested I take over an investigation that involved one of their employees.

During that investigation I witnessed an interview with [REDACTED] a now thirteen year old [REDACTED] who stated that about three weeks after going to Jamie and David Milligan's house that they made him inappropriately touch [REDACTED] a now eleven year old [REDACTED]. [REDACTED] a now thirteen year old [REDACTED] disclosed that Jamie and David Milligan told him to touch [REDACTED] a now eleven year old [REDACTED] privates. [REDACTED] a now thirteen year old [REDACTED] disclosed that while he and [REDACTED] a now eleven year old [REDACTED] were touching each other inappropriately that both David and Jamie Milligan would watch them and laugh.

I checked with Craig Hansen with the Children's Division who told me that according to the records at the Children's Division that both [REDACTED] and [REDACTED] were placed in the home of Jamie and David Milligan on 07/09/2010.

I witnessed and interview with [REDACTED] a now eleven year old [REDACTED] a now eleven year old [REDACTED] disclosed that while [REDACTED] was living with David and Jamie Milligan that they

made her and [REDACTED] a now thirteen year old [REDACTED] have sex. [REDACTED] a now eleven year old [REDACTED] disclosed that while the Milligan's were watching [REDACTED] and [REDACTED] a now thirteen year old [REDACTED] have sex that they were watching them and laughing [REDACTED] a now eleven year old [REDACTED] disclosed that after the Milligan watched [REDACTED] a now thirteen year old [REDACTED] have sex they went into the bedroom.

I spoke to David Milligan and he denied doing anything to either [REDACTED] or having or making them do anything to each other.
